## Rights of the data subjects

**MOON HOSTEL BIO SL** informs Users that they can exercise their rights of access, rectification, limitation, deletion, portability, opposition to the processing of their personal data, and the right not to be subject to automated decisions, including profiling, before the Data Controller, as well as the withdrawal of the consent given.

- Right of Access: This is the right of the user to obtain confirmation as to whether their data is being processed and, if so, the specific personal data being processed and the legal information regarding the processing (purposes, legal basis, retention periods, transfers, source of data, etc.)
- Right of Rectification: This is the right of the affected individual to have inaccurate
  or incomplete data modified. Regarding the website, this can only be fulfilled
  concerning information that is under the control of the website, for example, deleting
  comments posted on the page, images, or web content containing the user's
  personal data.
- Right to Limit Processing: This is the right to limit the purposes of processing originally provided by the data controller in specific cases.

- **Right of Deletion:** This is the right to delete the user's personal data, except as provided for in the GDPR itself (freedom of expression and information, retention obligations, formulation, exercise, or defense of claims, etc.).
- Right to Portability: The right to receive the personal data that
  the user has provided in a structured, commonly used, and
  machine-readable format, and to transmit it to another
  controller when the processing is based on consent or the
  execution of a contract and is carried out by automated means.

- Right of Opposition: This is the right of the user to prevent the processing of their personal data or to cease such processing by the website when the processing is based on legitimate interests or public interest or when it involves direct marketing processing.
- Right not to be subject to automated decisions, including profiling: When the
  processing is not necessary for the conclusion or execution of a contract, nor
  authorized by the law of the European Union or member states, nor based on
  consent, the individual has the right not to be subject to a decision based solely on
  automated processing, including profiling, that produces legal effects concerning
  them or significantly affects them in a similar manner.
- **Right to withdraw consent:** For any processing based on their consent, the user has the right to withdraw it at any time and free of charge.

To exercise any of the rights regarding data protection described above, you must follow these guidelines:

- Submit a written request to the address C/LUZARRA 7, 48014 BILBAO (BIZKAIA) (to the attention of MOON HOSTEL BIO SL) or via email to canaletico@moonhostelbio.com
- The request submitted by the data subject (interested party) requesting the exercise of rights must take the following into account:
  - They must be reliably identified, and if there are doubts about the identity of the requester, they will be asked to clarify the request (e.g., by providing more information, such as ID number, ID document, email provided, etc.).
  - The request can be made by a representative, legal or voluntary, as long as they are duly identified and authorized by the data subject (by means of an express authorization from the data subject to exercise the personal rights regulated in the data protection legislation).
  - Specify the request (the right(s) intended to be exercised). If it does not refer
    to a specific processing operation, a response will be provided regarding all
    processing that affects their personal data. If they request information about
    specific processing, only information regarding that processing will be
    provided. If requested by phone, they will be advised to do so in writing and
    informed how to do so and the address to send it to. Information will never be
    provided over the phone.
  - Postal or email address for notification purposes.
  - Supporting documents for the request being made, if necessary.
  - The requester must use any means that allows them to prove the sending and receipt of the request.

Finally, we inform you that you have the right to file a complaint with the Spanish Data Protection Agency if you become aware of or consider that an act may constitute a breach of applicable data protection regulations.

MOON HOSTEL BIO SL is committed to adopting the necessary technical and organizational measures, in accordance with the level of risks associated with the processing carried out by it as indicated in the terms and conditions of use, to ensure their integrity, confidentiality, and availability.
